## **Financial Policy**

All accounts are due on the 1st and must be paid by the 15<sup>th</sup> of each month. A \$20 late charge will be added to any account that is not up to date. If there is a problem in keeping an account current, parents should seek assistance with the principal. Every reasonable attempt will be made to work with families having difficulty.

## **Student Probation Policy**

All new students will be on probation for the first quarter (9 weeks) of school. If the student fails to make acceptable progress in any one or more of the following areas they may be dismissed anytime.

Academically - Cannot keep up with the pace of school and the rigor of curriculum Socially - Behavioral and discipline problems

Emotionally – Maturation is not at grade level

If there is a concern about the students' progress there will be a meeting with the principal and the parents to find ways for additional help for the student. If the student continues to not meet the standards of Liberty Christian School, the principal will, again, meet with the parents and the student to find ways to help the student succeed. If expectations continue to be unmet, Liberty Christian School has the right to dismiss the student from the school.

## **Enrollment Status Change Policy**
